2. A 25% dining discount will be applied to the food portion of your bill in the AquaTerra Restaurant (excluding tax and gratuity). A 50% dining discount will be applied on Mondays for the food portion of your bill only. One (1) Membership Dining Card will be accepted per check, sorry no exceptions. **Non-members are not entitled to the dining discount whether paying for a dining member's check or paying for their individual checks.**
3. **The Member or Cardholder must present his or her AquaTerra Dining Membership Card at all times when dining in AquaTerra, no exceptions.** Dining discount will only be applied after card has been presented.
4. An automatic 18% gratuity will be automatically applied to the total bill before discount is applied.
5. The AquaTerra Dining Program/Card is **NOT** applicable for purchases in Snack Bar or Beverage Cart.
6. The Dining Membership bought will be valid for one year from date of issue (includes Annual Benefits only-dining discounts and room discounts, does not include 'Complimentary Gift Certificate' expiring relative to the Member's Purchase Date of the Membership.)

Due to timing, service, and space issues in our restaurant, large parties of 15 or more can be booked in one of our banquet function rooms. As a reminder, Aquaterra Dining Members receive a 10% banquet and catering discount (not to exceed \$300) and can use this discount multiple times throughout the year.
